Job Description

S/he also will work closely with the MEAL department on technical matters and report to the MEAL Manager and the project manager.

 against the performance indicators (through the IPTT); and ensuring timely compilation and
 reporting of data.

- Support and contribute to lessons learned workshops for projects to capture achievements and challenges, and record proposed recommendations for future planning
